Notification of Collection and use of Social Security Number: FL statute 119.071(5); GCSC collects SSNs for use in performance of the College's duties and responsibilities for the following purposes: identification, verification, & creation of student records necessary for conducting the College's business; billing & payments; data collection; tax reporting. Federal law requires that we protect SSNs from disclosure to unauthorized parties. Federal legislation related to the Hope tax credit requires that all postsecondary institutions report the SSN of all postsecondary students to the IRS.
