INTENT TO AWARD: The GCSC Evaluation Selection Committee recommendation to the District Board of Trustees on April 13, 2017, is to award the contract to LandrumHR.

Award amount is 39.3% markup on hourly rate. For example, an employee @ 10.00 per hour x 39.3% = 13.93 total per hour. Contract is for 3 years from the date of Notice to Proceed. Requirements of RFP#3-2016/2017, require Level II criminal background checks on all employees recommended to the college, employment verifications, and reference checks and drug screening if necessary or requested by the college.

Vendor agrees if college decides to hire temporary employee as a permanent full time employee that the college reserves the right to hire temporary service person with no additional cost to Gulf Coast State College. Vendor agrees there is no required amount of hours of work before college can hire an employee permanently.

BID PROTEST:

After posting of recommendation of award, any bidder or proposer who is aggrieved in connection with the pending award may protest to the Procurement Director in accordance with the GCSC Procurement policies, Sec. 120.57(3), Florida Statutes. Failure to file a notice of protest or failure to file a formal written protest with the proper bond shall
