This Addendum is hereby made part of the Contract Documents of the RFP.

## **RESPONSE TO WRITTEN QUESTIONS RECEIVED:**

**Question #1:** A statement was made at the Pre-proposal meeting about the front of the building being flat in the new design. Does that area have to be flat?

 <u>Response:</u> This is a proposal not an Invitation to bid, therefore the proposer has the right to any approach you find necessary as long as you meet the requirements set forth in RFP#5-2016/2017. Consider the slope on the front on building because the visibility of the Amelia G Tapper Center is important and the name on the building must remain visible. The front area design must not take away from the aesthetics of the entire project.

**<u>Ouestion #2:</u>** Are the metal roofing panels required to be Aluminum?

Response: The RFP requires that it's some type lightweight metal truss system with a standing seam metal roof. If there is another product that matches the look of the metal standing roof panels and provide a 20-year warranty then it would be acceptable.

Question #3: Are any of the mechanical or electrical curbs abandoned or obsolete?

Response: Proposals should be based on all curbs, pipes, equipment and etc being raise to the correct elevation on new roof.

Question #4:Are the smoke hatches staying?☆Response: The plan was for them to stay.

<u>Ouestion #5:</u> Does the Gutters and Downspouts sizes fall on the contractor? ☆ <u>Response: It falls on the roof designer.</u>

**<u>Ouestion #6:</u>** Does the college require a minimum of 3" of roll insulation under the panels?

Response: The Designer needs to make the recommendation to the college in their proposal to meet all codes, and requirements. Meet the scope of work per RFP#5-2016/2017. If a designer decide to recommend it to the college, the importances may need to be expressed in the Approach and Understanding.

**<u>Ouestion #7:</u>** Where will the laydown yard be located?
