 - o Bay County Tax Parcel 27931-010-000—Moody Avenue property
- The Department of Transportation will pay the college's attorney fees and expert fees and costs.
- The Department of Transportation will make modifications to Collegiate Drive, other areas in, and surrounding the college to the satisfaction of staff, Chair Roberson, and President Holdnak.
- Chair Roberson, President Holdnak, and Counsel are authorized to negotiate and execute all settlement documents provided such documents include at a minimum the obligations stated above.
