**I. Welcome** Mr. Crisp welcomed and called the meeting to order at 8 a.m.

II. Public Records Mr. Bennett distributed a document outlining the Florida Sunshine Law

and reviewed the general history of how the law was created, noticing of meetings (including committee meetings and workshops), exemptions, communication among trustees, solicitations of gifts, voting conflicts, and e-mail responsibility. All public records requests should be directed

III. Board Dr. Holdnak presented the current board committee structure and suggested that the Manual of Policy be modified to include the ac

preferences.

IV. FoundationUpdateDr. Holdnak updated trustees on the Foundation and stated that the Board of Directors would like to plan a joint meeting with the District

Board of Trustees in the fall. Mr. Crisp appointed Mr. Lewis as the

trustee liaison to the Foundation.

V. Parking/ Dr. Holdnak reported that Phase I of the Parking Lot Paving Project is wrapping up with completion expected on August 21. The architect and engineer are working on the design for the next phase of the project, and

Dr. Holdnak asked trustees for direction on the options previously presented for the STEM building and parking garage. Trustees

discussed flat parking, constructing a parking garage with the option of

either adding one or two floors to the STEM building, or constructing separate parking and STEM facilities. Trustees expressed concerns about locating an unsightly parking garage on prime real estate at the new entrance to the College. Following considerable discussion, Mr. Crisp suggested an August workshop/meeting to determine the location and cost for each of the following options as well as the costs associated with relocating the softball field and completion of the internal roadway:

- Option 1—Building separate parking and STEM facilities
- Option 2—Building a parking garage and first floor STEM facility
- Option 3—Building a parking garage, first floor STEM facility, and phasing an additional floor to the STEM facility
