Special Presentation

Dr. Holdnak introduced Ms. Becca Hardin, executive director, Bay Economic Development Alliance, and Mr. Clint Mizell, chair, Bay Economic Development Alliance and invited them to update trustees about recent EDA activities. Mr. Mizell expressed his appreciation to Dr. Holdnak and the College for the tremendous support and great leadership the EDA has received. Ms. Hardin presented a video outlining the benefits of the close EDA/CareerSource/GCSC/FSU PC/Port Panama City partnership, which has resulted in major manufacturing, logistics/distribution, IT, and entrepreneurial prospects considering this area. She stated that the main mission of the Bay EDA is to create jobs and to infuse capital in the community and the impact of the College has been instrumental in bringing several projects to Bay County. Dr. Holdnak noted that the College's service district includes Bay, Gulf, and Franklin counties and that the EDA was working with Florida's Great Northwest to improve job creation regionally.

2. Trustee Comments

Mr. Crisp called on each trustee for comments. Mr. Lewis 2.1 commented on the recent beautiful weather and on how grateful he was that the election season was over. Mr. Warriner welcomed the new SGA president and requested an update on the progress of the McSpadden Student Union East renovation. Mr. McKnight expressed his appreciation that the election season had ended and recommended that civics be brought back to the curriculum to educate students on the process of American government. Mr. Roberson noted the progress on the flyover project and stressed the importance it would have on improving the flow of traffic. He thanked Ms. Hardin and Mr. Mizell for their efforts in bringing new opportunities to this region of Florida and expressed his excitement about Eastern Shipbuilding locating to Gulf County and the future training opportunities the College can provide to their employees. Ms. Patronis thanked the EDA for their efforts and for the strong partnership with the College, attended the Shark's Tooth Pairing Party and the Kirby Holt Decorating Showcase, noting the importance of community members attending these events to bring exposure to the College; and recently spoke with FSU PC Interim Dean Hanna about the continued, improving partnership between FSU PC and GCSC to provide more access for students. Mr. Tannehill wished trustees, faculty, administrators, and staff a happy Thanksgiving and thanked them for their efforts in assisting students. Mr. Millaway stated that the Bay County EDA is doing an amazing job and noted the incredible progress made in the last year in Bay County and regionally.

GCSC Foundation, Inc. President's Update

Mr. Jeff DiBenedictis, president, GCSC Foundation, reported that beginning October 18 and ending November 15, 2016, the Foundation received approximately \$81,768 in private contributions from the community; as of October 2016, the Foundation's assets stand at \$30.1 million, which is a small decrease from the previous month; the year-to-date program support of the College is \$573,300; and ending October 2016, year-to-date investment activity reported a gain of \$741,000. Mr. DiBenedictis stated that the Foundation received an unqualified opinion with no findings on their 2015-16 financial audit.

The Gulf Coast State College Foundation Annual Golf Tournament at Shark's Tooth Golf Club was a successful event, with 120 golfers participating and 46 tee signs on the course, netting \$50,000 for scholarships to benefit first generation military and veteran students.

In preparation for the 2017-18 scholarship application cycle, a series of scholarship workshops as well as the High School Counselor Breakfast would be occurring throughout the months of November and December.

Tentative Approval of Manual of Policy Changes

4.8

Trustees were asked to provide tentative approval for the following Manual of Policy revisions:

Policy 6.063, Fringe Benefits for Temporary and Part-Time Employees

The current policy is being updated to reflect that temporary, full-time faculty are eligible to receive benefits during their contract period. It is also being updated to reflect that part-time coaches are eligible for medical insurance and that the College will provide benefits to part-time employees who qualify under the Affordable Care Act mandate.

Policy 6.064, Retirement Programs

Florida Statue allows for a CCORP participant at normal FRS Pension Plan retirement to receive distributions based on the FRS Investment Plan structure, with 10 percent on the first of the month after 30 days of retirement and the remaining 90 percent on the first of the month after 90 days of retirement. Board approval is required in order for TSA Consulting to add this to our distribution option in our plan.

Policy 6.105, Drug-Free Campus and Workplace

This change reflects the Drug-Free Schools and Communities Amendment of the 1989 requirement to publish the College's Drug and Alcohol Abuse Prevention Program.

Policy 6.109, Vulnerable Persons Act

This policy is being updated to properly include all levels of responsible parties.

Policy 7.024, Laboratory and Special Course Fees

This policy update is to decrease the frequency of reviewing lab fee documentation to once every three years, which will improve the efficiency and accuracy of the process.

She currently teaches a political science course and stated that her focus is to educate students on the meaning of civic engagement and its impacts on the community. She noted that Supervisor of Elections Mark Anderson presented at the September CLEAR Conference and that she is communicating with former Senator Bob Graham's office about speaking at the spring Leadership Conference.
