#### 5. Action Items

Recommendation to Add Women's Cross-Country for the 2024-2025 Academic Year 5.1

Mr. McDonald stated that Athletics staff have been working diligently to ensure the College's athletic program is compliant with NJCAA and state regulations for Title IX equity requirements. He informed that in recent years, the state equity report has shown that the College is not in compliance with female athletic offerings based upon the percentage of females that attend the College. He explained that with the ongoing trend of growing female enrollment, the Athletics Department recommended the addition of a women's cross-country team to increase female participation.

Mr. McDonald reported that in the counties of Bay, Gulf and Franklin, 8 out of 9 high schools offer cross-country and in addition to that, 43 out of 51 High Schools in the 12 surrounding counties offer cross-country. He noted that in the Panhandle Conference, Chipola and Tallahassee currently offer cross country and Pensacola is in the process of creating their own team.

Mr. McDonald informed that the Athletics Department recommended the addition of a women's cross-country team for the 2024-2025 academic year. He noted that the plan is to have at least a team of 10 athletes, allowing additional walk-on participants.

Mr. Powell moved to accept the recommendation to add women's cross-country for the 2024-2025 academic year as presented. Mr. Tannehill seconded, and the vote was recorded as follows: Berry, aye; Bulger, aye; De La Rosa, aye; Hall, aye; Powell, aye; Skinner, aye; Tannehill, aye; Windham, aye; and Cramer, aye.

Recommendation of Approval of the 2024-2025 Gulf Coast State College Academic Calendar Mr. McDonald stated that each year the College is required by the Department of Education to have the academic calendar approved by the Board of Trustees. He informed that the parameters (range of dates) when we can start an academic term is provided by the Florida Department of Education (FLDOE) and the College must ensure that it meets the number of instructional hours.

Mrs. Berry moved to accept the 2024-2025 calendar as presented and Mr. Skinner seconded, and the vote was recorded as follows: Berry, aye; Bulger, aye; De La Rosa, aye; Hall, aye; Powell, aye; Skinner, aye, Tannehill, aye; Windham, aye; and Cramer, aye.

Recommendation to Approve Modification of Land Use for Bay County Sheriff's Department Mr. McDonald recognized Sheriff Tommy Ford attendance and informed that he was awarded the Leroy Collins Lifetime Achievement Award by the Association of Florida Colleges on behalf of Gulf Coast State College.

Chair Cramer congratulated Sheriff Ford for his achievements.

Mr. McDonald stated that Bay County Sheriff's Office (BCSO) contacted the College regarding a change to their helipad and building on property currently leased from the College at the North Bay Campus. He informed that the original plan was to take down the existing building and replace it with a larger, redesigned facility to accommodate a larger, recently acquired helicopter, and the existing two helicopters.

Mr. McDonald explained that more recently, however, the BCSO was informed by the Department of Environmental Protection that there would be significant mitigation efforts required due to a stream that runs adjacent to the current site with costs estimated at approximately \$200,000, making the project no longer viable given the project budget. As a result, the BCSO has asked about to build a new hanger in the area between the old ShandsCair pad and the wooded area to its east, which is close to the area that Bay County had previously leased for construction of a new fire station, a plan that was ultimately abandoned. Mr. McDonald noted that there will be no cost to the College and the BCSO would do all the permitting, design, construction, etc.

Mr. McDonald requested approval by the board to engage Mr. Bennett, the College attorney, to work with representatives of the BCSO and Mr. John Mercer to develop a lease and/or Memo of Understanding beneficial to both parties to accommodate this request as it is a benefit to the College and to the community.

Ms. Windham moved to approve modification of land use for Bay County Sheriff's Department as presented. Dr. De La Rosa seconded, and the vote was recorded as follows: Berry, aye; Bulger, aye; De La

Rosa, aye; Hall, aye; Powell, aye; Skinner, aye, Tannehill, aye; Windham, aye; and Cramer, aye.

Sheriff Ford stated that he was honored and humbled by the award. He expressed gratitude to Gulf Coast Community College for its contribution to the community and thanked the board for approving the modification of the land use at North Bay Campus.

#### President's Report 6.4.1

- **6.4.1** Mr. McDonald reported the following:
  - Gulf Coast State College has been invited to apply for the 2025
     Aspen Prize for Community College Excellence. GCSC is 1 of
     the 150 community colleges out of approximately 1,000
     nationwide that has been invited to apply for the \$1 million
     Aspen Prize.
  - GCSC has been recently listed by the Military Times as "Best for Vets" and was ranked in the top 5% of all colleges and universities in the United States.
  - A new GCSC application went live on November 13<sup>th</sup>. Feedback received from students and high schools' counselors have been positive.
  - BayWay public transportation is getting more popular with students and employees, as the number of users has been increasing monthly.
  - The women's volleyball team is currently competing at the NJCAA DII national championship in Cedar Rapids, Iowa.

- Women's basketball is currently ranked NJCAA #2 nationally with a 5-0 record.
- Men's basketball has also started their season with 5-0, and on the community front, the team helped the Boys and Girls Club unload Christmas trees yesterday morning.
- The Public Eye Soar demonstration was conducted on campus from November 10<sup>th</sup> through the 11<sup>th</sup>. The event brought over 2,500 guests to campus. Mr. Jason Hedden will report on the even at the January board meeting.
- The College experienced a power outage yesterday morning due to an off-campus issue. Power was fully restored around 11:00 a.m. and classes resumed at 12:30 p.m. The College's alert system was put to the test and performed well for employees and students.

Unveiling of Dr. Holdnak's Presidential Portrait **6.4.2** Mr. McDonald welcomed Dr. John Holdnak, family and friends. He asked Mr. Cramer to unveil Dr. Holdnak's presidential portrait.

Chair Cramer stated that it was a special day as the College honors and celebrates the remarkable career of Dr. John Holdnak, the 6<sup>th</sup> president Gulf Coast State College. He noted that Dr. Holdnak's contribution to the College has been extraordinary and his legacy will endure for generations to come. He added that throughout Dr. Holdnak's 34 years at GCSC, including 8 as president, he displayed unwavering leadership in various capacities across the campus, demonstrated by his involvement in Student Government, Athletics, Human Resources, Student Affairs, and many other areas exemplified his commitment to the holistic development of the College.

Chair Cramer explained that, under Dr. Holdnak's leadership, the College weathered the devastating impact of Hurricane Michael and a global pandemic, ensuring the continuity of education by transitioning the College's learning environment online. He pointed out that we celebrate not only Dr. Holdnak's ability to navigate through those storms, but his lasting impact on the College's growth, innovation, and academic excellence. Under his stewardship, GCSC has proved to be a beacon of knowledge and opportunity, enriching the lives of countless students, faculty, and staff.

Chair Cramer voiced that Dr. Holdnak's tenure as GCSC president is etched into the history of Gulf Coast State College, serving as an enduring source of inspiration for future generations. He expressed gratitude for Dr. Holdnak's dedication, unwavering commitment, and

exemplary service to the College.
