Dear Candidate:

Enclosed is the application packet that you requested for the Florida Law Enforcement Academy. Please read this cover letter, as well as all of the information contained within. Pay particular attention to the sections on candidate qualifications; and, application procedures. Most of the questions frequently asked by applicants are answered in this packet.

No one will be accepted into the Academy if they have had any felony conviction; or, any misdemeanor conviction involving perjury, false statement, or a moral character violation as defined by the Florida Department of Law Enforcement's Criminal Justice Standards and Training Commission.

Additionally, Federal Law prohibits any individual who has been convicted of a Domestic Violence charge (Felony or Misdemeanor) from being in the constructive possession, or of carrying, a firearm. This law prohibits an individual with such a conviction from becoming a Law Enforcement Officer. Also, if you possess a Felony charge on your Juvenile record; and were adjudicated delinquent on said felony, you cannot be in the constructive possession of, or carry, a firearm until you reach twenty-four (24) years of age.

The purpose of the law enforcement program is to prepare students for employment as Law Enforcement officers within the State of Florida. The program consists of courses mandated by the Florida Department of Law Enforcement for certification as a Law Enforcement Officer. Students who graduate from this program would typically work as either a Municipal (City), County, or State, Law Enforcement Officer. The classes that comprise the academy are: Intro to Law Enforcement, Legal, Communication, Interviewing and Report Writing, Fundamentals of Patrol, Serving Your Community, Crimes Against Persons, Crimes Against Property and Society, Crime Scene Follow up Investigations, Traffic Incidents, Traffic Stops, Traffic Crash Investigations, Critical Incidents, Law Enforcement Vehicle Operations, First Aid for Criminal Justice Officers, Criminal Justice Firearms, Criminal Justice Defensive Tactics, Dart Firing Stun Gun, and Criminal Justice Officer Physical Fitness. The aforementioned eighteen (20) classes comprise 770 contact hours; or, 25.7 PSAV certificate hours.

Academy classes are conducted in a college classroom setting, as well as in practical lab areas. Basic Law Enforcement recruits, while GCSC students, must conform to stricter attendance policies, wear uniforms, and agree to abide by not only the policies and procedures of Gulf Coast State College as a whole; but, to the additional policies and procedures of the Law Enforcement Training Academy as directed by the Basic Recruit Manual that all students receive during class orientation.

## **CANDIDATE OUALIFICATIONS**

In order to comply with the provisions of Section 943.13, Florida Statutes, the following qualifications are required to be met for the position of law enforcement officer:

- 1. Candidates must be nineteen years of age or older; or, reach the age of nineteen by the end of the class.
- 2. Candidates must be citizens of the United States.
- 3. Candidates must be high school graduates or possess a GED
- 4. Candidates must be of good moral character
- 5. Candidates must not have been convicted of any Felony; or, Misdemeanor involving Perjury, False Statement, nor have received a Dishonorable Discharge from any of the Armed Forces of the United States. Any person who, after July 1, 1981, pleads guilty or Nolo Contendere to, or is found guilty of, a Felony or of a Misdemeanor involving Perjury, or False Statement, shall not be eligible for employment or appointment as an officer; notwithstanding suspension of sentence, or withholding of adjudication. Notwithstanding this subsection, any person who has pled Nolo Contendere to a Misdemeanor involving a False Statement, prior to December 1, 1985, and has had such record sealed or expunged shall not be deemed ineligible for employment or appointment as an officer. Additionally, Federal Law prohibits any individual who has been convicted of a Domestic Violence charge (Felony or Misdemeanor) from being in the constructive possession of, or carrying, a firearm. This law prohibits an individual with such a conviction from becoming a Law Enforcement Officer. And, if you possess a Felony charge on your Juvenile record, and were adjudicated delinquent on said Felony, you cannot be in the constructive possession of, or carry, a firearm until you reach twenty-four (24) years of age.
- 6. Candidates must provide confirmation of one of the following:
  - a. Confirmation of veteran status (copy of DD-214 noting honorable or general discharge under honorable conditions), as defined in F.S.S. 1.01 (14), "A person who served in the active military, naval, or air service and who was discharged or released under honorable conditions only or who later received an upgraded discharge under honorable conditions."
  - b. confirmation of associate degree or higher from an accredited college or university (copy of a conferred associate degree or higher and official transcripts).
  - c. completion of the BAT with a passing score.

#### To register for the Basic Abilities Test, please visit (<u>https://home.pearsonvue.com/fdle/bat</u>) Driver's License and your original Social Security card are required when you come to test. Failure to have BOTH of these cards with you will result in you not being able to test. No photocopies or pictures of the cards will be accepted.

these cards with you will result in you not being able to test. No photocopies or pictures of the cards will be accepted. You must bring the original cards with you. If you don't have your original Social Security card, you will have to request one from the Social Security office which can take 3-6 weeks for you to receive the card in the mail.

\* Registration and payment through the PearsonVue website must be made before you will be permitted to take the BAT test. You can pay for it several days before; but, at least one working day before the test. Saturday is <u>not</u> considered a working day. If you schedule your test on a Monday, then Friday will be the last day that you can pay for the BAT to test on Monday. <u>It is your responsibility to have a copy of the receipt with you when you come to test</u>. Failure to do so may result in you not being able to test that day. Showing a photo of the receipt on your phone will not be accepted. If you do not show up for the test, your fee is non-refundable.

- \* There is a 72 hour registration deadline. You can't register for a test tomorrow, today. There must be a 72 hour difference. For Example: If you want to test on a Wednesday at 10am, you must complete your registration BEFORE Sunday at 10am. Use the arrow key to show the next month if you don't find one that suits you in the current month. Be sure your email address is correct. When you have completed your BAT registration, you should receive a confirmation email of your appointment. If you do not get a confirmation email, it could be that the appointment didn't go through or your email address is incorrect. Be sure you click the button that says "complete registration". In the event that you don't get a confirmation email, try to make the appointment again to get your confirmation email. You can cancel/reschedule your own appointment by going to your email confirmation and following the instructions.
- \* The GCSC Testing Center located in the Student Union West (SUW) Building on the Panama City Campus is one of the testing locations available in this region. The address is 5230 West Hwy. 98, Panama City, FL, 32401. There will be a "SIGN IN" computer by the elevator. If you have any questions, you can call 850-769-1551 Ext. 13336. 7. In accordance with Section 943.14 (7), Florida Statutes, you must submit to being fingerprinted in order to determine/check your criminal history (Cost = \$85), in order to attend the Academy. If you have EVER been convicted of any Felony; or, any Misdemeanor involving Perjury, False Statement, or any charge relating to Domestic Violence, you are ineligible to become certified as a Law Enforcement Officer in the State of Florida. Additionally, if you were convicted of a Felony as a Juvenile you cannot be in the constructive possession of a firearm until you are twenty-four years of age; and, will therefore not be able to attend the Law Enforcement Academy until said age is attained. NOTE: Fingerprinting appointments are scheduled through Register Blast which can be accessed by going to the following link: https://www.registerblast.com/gcsc-fingerprint/resource/list.

On the day of your appointment, please go to the Selection Center located on the North Bay Campus (700 Hwy 2300, Southport, FL, 32409), in the Public Safety-Emergency Operations Center Building, in Room 112. Ms. Stephanie Driskill will process the background check and collect your fingerprints at the time of your appointment. Please note that payment MUST be made in advance of your appointment. You must also provide Ms. Driskill with your payment receipt.

You can pay the fingerprint fee by either calling the Business Office (850-769-1551 Ext. 13534 or 16049); or, by going to the Business Office or the Bookstore at the Panama City Campus. you will FORFEIT YOUR FINGERPRINT FEE.

8. Candidates must submit to, and successfully pass, a Physical Examination (your cost) performed by a Florida licensed Physician (MD), Nurse Practitioner (ARNP); or, Physician's Assistant (PA). The Physician MUST complete and sign the attached CJSTC Form 75 (Physician's Assessment Form) attesting that no medical condition exists which would preclude them from participating in Physical Fitness Testing, Physical Fitness Conditioning, Firearms Training, Defensive Tactics Training, or being exposed to, or contaminated with, the chemicals oleo-resin capsicum (OC) and/or orthochlorobenzal-malonotrite (CS). The Physical Examination also requires a test for Tuberculosis (TB) which generally takes a few days to test/process by the Physician's office; so, plan accordingly as the Physical Examination Form (CJSTC Form 75) MUST be completed, and turned in, PRIOR to the Class Orientation – NO EXCEPTIONS. No one will be permitted to participate in the aforementioned areas of training, or testing, without the CJSTC Form 75 completed and in their candidate file. If your physician does NOT recommend your participation at this time, your admission to the Academy will be suspended until your Physician deems you capable of participation and medically releases you for the aforementioned training and testing. If for any reason, medical or otherwise, you cannot be exposed to, or contaminated with, the chemicals oleo-resin capsicum (OC) and/or orthochlorobenzal-malonotrite (CS), you will not be able to attend the Academy.

## APPLICATION PROCEDURES

COMPLETE THE BASIC ABILITIES TEST [COST = \$39] (Law Enforcement Option), or provide proof of eligibility for exemption from the BAT. *Detailed instructions concerning scheduling, and taking, the CJBAT or exemption are listed on Pages 3 & 4 of this packet under "Candidate Qualifications" (Number 6).*
- 4. SUBMIT TO AND SUCCESSFULLY COMPLETE THE BACKGROUND INVESTIGATION [COST = \$85] Detailed instructions concerning scheduling, and being, Fingerprinted are listed on Page 4 of this packet under "Candidate Qualifications" (Number 7).
- 5. COMPLETE THE FOLLOWING ATTACHED FORMS: Personal Data Form; Certificate of Application; Domestic Violence Conviction Affidavit; Statement of Understanding; Affidavit of Non-Military Service (if Applicable); Criminal Justice Selection Center Background Check Form; Authority for Release of Information (CJSTC Form 58); Federal Gun Control Act Form, Physician's Assessment Form (CJSTC 75); Applicant Authorization; and Applicant Certification

- 1. I understand that I must participate in all of the required courses of the Academy.
- 2. I understand that I must pass all written examinations with a score of 80% or greater.
- 3. I understand that I must also pass all proficiency examinations in the areas of Vehicle Operations, First Aid for Criminal Justice Officers, Criminal Justice Firearms, Criminal Justice Defensive Tactics, and DUI Traffic Stops; and, that I must actively participate in all training scenarios as required.
- 4. I also understand that I must show physical fitness improvement over the course of the Academy as measured by a physical fitness exam (The first physical fitness exam will be held within the first two weeks of the Law Enforcement Training Academy; and, the second physical fitness exam will be held during the last two weeks of the Law Enforcement Training Academy).
- 5. I understand that I must participate actively in all phases of Defensive Tactics training.

These activities include but are not limited to:

- A. Falling or being thrown onto Mats.
- B. Punching, kicking, and throwing other students; and, being punched, kicked, and thrown by other students.

- D. Using controlling and/or disabling pressure point techniques on others; and, having those techniques applied to me.
- E. Receiving / giving baton strikes.
- F. Executing a number of defensive tactics techniques on other students; and, having those techniques applied to me.
- G. Being exposed to, or contaminated with, the chemicals oleo-resin capsicum (OC) and/or orthochlorobenzal-malonotrite (CS), commonly known as "pepper spray" and that this will cause me temporary discomfort.

    - **300 Meter Run.** This measures anaerobic power, or the ability to make an intense burst of effort for a short time period or distance. This component consists of sprinting 300 meters as fast as possible.

## ATTENDANCE STANDARDS – CRIMINAL JUSTICE TRAINING ACADEMY

## A. CRIMINAL JUSTICE ATTENDANCE POLICY – FDLE Standards and Training Commission Rule 11B-35 (Class 3 Violation)

1. Students are expected to attend all classes and participate in all classroom activities. However, recognizing that emergencies occur, any student absent for more than one class period that does not communicate their absence to the class instructor, and program coordinator, and the reason(s) for said absences will be removed from that particular course of instruction and assigned an "F" as the final course grade.

If a student wishes to withdraw from a particular class, they must submit their withdrawal prior to the scheduled withdrawal deadline as published within the GCSC catalog. These withdrawals will ordinarily be recorded as a grade of "W". The withdrawal deadline for an off-term or condensed term is one week after midterm.

Withdrawals initiated prior to midterm will be recorded as "W". Withdrawals initiated after the mid-point of midterm will be recorded as a "W" if passing, and an "F" if failing.
