#### AMH 2020 Catalog/Course Description and Broad Goals:

- This course is a history of the United States from 1876 to the present day. The course includes the growth of big business, the Agrarian Revolt, Latin American affairs, the Progressive Movement, the World Wars, and political economics and world affairs since World War II.
- This course is primarily lecture and reading based, with opportunities for discussions via the Canvas Discussion Board.
- The broad goals of the course include students learning and retaining a significant amount of historical information; developing critical thinking and deductive reasoning skills; and, improving communication skills.

**Teaching Techniques:** The means of content delivery for this course includes classroom lectures and discussion, PowerPoint presentations, one-on-one correspondence, educational videos, and supplementary websites.

#### **Student Learning Outcomes:**

Upon successful completion of AMH 2020, students will be able to:

1) Demonstrate that they have learned the factual details of the substantive historical episodes during the period under study.

2) Identify foundational developments that helped shape Post-Reconstruction, Industrial, and Contemporary American history.

3) Demonstrate college-level knowledge of the primary events, ideas, values, and perceptions that have shaped American history.

#### **Instructor-Specific Learning Objectives:**

AMH 2020 students will demonstrate that they have gained the basic, factual material on American history; demonstrate that they have learned the major, historical

interpretations; and, demonstrate that they have improved their analytical and communication skills.

Moreover, upon completion of AMH 2020, each student should be prepared to address the following questions concerning American history:

- Which primary forces, ideologies, or other factors and considerations forged American history?
- How has the role of America changed over time?
- What have been the leading political, social, and constitutional implications of the various transformations/transmutations of the American experience?
- How has your understanding of American history been shaped or reshaped by this course?
- The leading topics in this course will include: Reconstruction, the rise of big business, developments in the western US, the Populist and Progressive Eras, American imperialism; the rise of the Imperial Presidency, America and World War I, America during the 1920s, The Great Depression, World War II, the Cold War, the Korean War, the Vietnam War, and major changes that fundamentally impacted the United States from the 1970s.
