**Course Description:** Understanding Visual Arts is a general introduction to the study and appreciation of visual art. - Give a brief but comprehensive history of art.

### **Withdrawal Policy:**

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. There are two kinds of withdrawals---student and administrative.
