PSY 2012 Course Description and Broad Goals: This course is a study of the general field of psychology and is designed to provide an understanding of human behavior by studying the adaptation of the individual to his/her physical and social environment.

Teaching Techniques: The techniques used for content delivery in this course center on creative and engaging online discussions, textbook readings, and information from a wide range of other scholarly materials.

Student Learning Outcomes: Upon successful completion of PSY 2012, students will be able to:

- Categorize the various approaches, fields, and subfields of psychology along with their major concepts and important figures in these domains.
- Identify preeminent theories, principles, and research findings, and give examples of psychology's integrative perspectives and concepts by applying them to everyday life.
- Demonstrate an understanding of psychological theories regarding the relationship between physiology, cognition, and emotion.
- Explain how humans become self-aware, how we learn to interact with others, how we influence others, and how they influence us.
- Classify the strategies with which psychologists study human behavior and how this knowledge is used to explain, predict, and influence behavior.

UNIT 1 – FOUNDATIONS OF PSYCHOLOGY

- Evaluate psychological research using the scientific method and ethical guidelines.
- Select appropriate research designs for real-world problems.

- Evaluate the accuracy and reliability of resources.

UNIT 2 – BIOLOGICAL PSYCHOLOGY

- Differentiate the functions of multiple brain structures.
- Create an individualized optimal sleep plan.
- Evaluate the scientific merit of multiple dream theories.

UNIT 3 – COGNITIVE PSYCHOLOGY

- Assess personal intelligence using multiple models and types of intelligence.
- Evaluate the effectiveness of memory strategies.
- Identify examples of various types of cognitive bias.

UNIT 4 – SOCIAL PSYCHOLOGY

- Examine the impact of multiple forms of social influence.
- Analyze personal use of various types of behavioral attribution.
- Identify real-world examples of various types of prejudice and discrimination.

UNIT 5 – DEVELOPMENTAL PSYCHOLOGY

- Explain real-world examples of classical conditioning.
- Plan ways to effectively use operant conditioning in the real-world.
- Explain potential personal examples of epigenetic inheritance.

UNIT 6 – PERSONALITY PSYCHOLOGY

- Describe variations of gender identity and gender expression.
- Analyze major perspectives in personality theory.
- Evaluate the reliability and validity of multiple methods of personality assessment.

UNIT 7 – CLINICAL PSYCHOLOGY

- Describe techniques psychologists use to prevent, diagnose, and treat mental illness.
- Recognize symptoms of various psychological disorders.
- Create treatment plans using a variety of appropriate psychotherapy techniques.

Course Requirements. Students enrolled in this course will be required to:

- Listen to and take thorough notes on the digital lectures assigned with each weekly Learning Module—I cannot overstate the importance of the digital lectures
- Read all of the textbook pages assigned with each Learning Module
- Contribute to the Discussion Boards when assigned
- Complete Writing Assignments when assigned
- Complete all required exams AS SCHEDULED (see the course schedule on Canvas).
- Contact the instructor via email at once with any problems or issues. I cannot handle problems unless you make me aware of them.

Student Expectation Statement: The student is expected to participate in the course via e-mail exchanges with the instructor, by listening to and taking thorough notes on all digital lectures, by reading the assigned readings, by submitting the required essays and writing assignments, by contributing to the Discussion Board, and by completing all required exams as scheduled.

All assignments uploaded into a Canvas drop box will automatically be processed through the plagiarism software called Turnitin. Turnitin (TII) provides a score that indicates the degree to which the information in the submission matches information from millions of available sources. High TII scores indicate large amounts of material have been taken from other sources. All TII scores are checked to ensure that proper and appropriate citations are used for material taken from another's ideas, writings, theories, media, etc. In the event an assignment is found to not be properly cited, the material will be considered plagiarized and the submission will receive a zero. It is critical that students review their TII scores for each submission and make corrections or revisions. Canvas allows for multiple uploads into a drop box, so feel free to upload as many revisions as needed to address any issues or citation problems.

Assessment Instruments:

- I. Upload signed Online Students Guidelines (see last page of syllabus) to Canvas no later than 11:59 PM on 15 January 2023. (5 points)
- II. Why Psychology? Essay (50 points): The Why Psychology? Essay should be submitted as a Word document directly into Canvas no later than 11:59 PM on 22 January 2023. This brief assignment requires you to draft a 250–300-word essay about why you are taking this course and what you hope to learn. Must be uploaded using one of these four file types: .doc, .docx, .rtf, or .pdf.
- III. Exams (150 points each):
 - All exams will be comprised of multiple-choice, true-false, and short answer questions. Each exam will be available for a specific time period.
 - The exams will be delivered online via Canvas.
 - The exams will be timed; each is strictly closed book and closed notes.
 - The final exam will be comprehensive with stronger focus on modules not covered by previous exam.
- IV. Writing Assignments/Discussion Board Contributions (360 points): Most weeks will either have a writing assignment or Discussion Board contribution. Exam weeks will have neither.
 - Writing Assignment: See prompts in Canvas for topics of writing assignments. Assignment should be at least 200-250 words and submitted via word doc to Canvas. Writing assignments will be due Sundays by 11:59 PM
 - Discussion Board: On weeks assigned, “Main” initial response will be due by 11:59PM on **Wednesdays** to be eligible for full credit to allow time for others to respond, and the remaining two required “follow up” posts are due before midnight the following **Sunday**. All contributions should add substantively to our discussion and generate further discussion and additional in-depth analysis. Discussion board posts will be graded in the following manner: DB assignment worth 30 points will be graded in this way: “Main” initial response

to the primary DB prompt = 20 points, and two “response” posts to classmates’ posts = 5 points each, Total= 30 points

- V. **Final Essay (50 points):** In at least 450-500 words, pretend you are a psychotherapist and have appointments today with TWO clients. You will have an opportunity to diagnose and provide two therapeutic strategies to help each of your "clients". See Canvas for more details. The Final Essay should be submitted as a Word document directly into Canvas no later than 11:59 PM on 28 April 2023. Must be uploaded using one of these four file types: .doc, .docx, .rtf, or .pdf.
- VI. There will be no “individual-only” extra credit offered; occasionally, I will offer extra credit only for all students in a class. I typically offer at least one opportunity for extra credit throughout the semester.
