Curriculum

Course Description:

LIT 2000, Literature and Culture, 3 hrs., 3 crs.

Prerequisite: ENC 1102 with a minimum grade of “C.” (Meets Area III Humanities Requirement.) Major writers, literary movements, forms, and themes of literature. This course is a Gordon Rule writing course in which students will produce extensive college-level writing and which requires completion with a minimum grade of “C.”

Cultural Sensitivity

You may encounter controversial issues, language, and discussions during this semester. All controversy must be approached in a sensitive and mature manner. In addition, disrespectful behavior toward another person or body of people will not be tolerated.

Goals

The purpose of the course is to foster in students the ability to approach literary works as cultural artifacts from a variety of critical perspectives.

Student Learning Outcomes

1. Students will demonstrate knowledge of assigned readings through objective and subjective test materials to be graded by the instructor.
2. Students will demonstrate knowledge of assigned readings through written essays to be evaluated according to a rubric for literary analysis.
3. Students will demonstrate competency in the use of standard English and MLA style.

Student Expectations of the Instructor

At least ten office hours will be held each week during the semester

We will make extensive use of Canvas, a course management program that allows you to turn in your work and take quizzes online, keep track of your grades, communicate easily with me and other students in the class, etc. **You must turn in all assignments on Canvas.**
