## **Course Description:**

## LIT 2000, Literature and Culture, 3 hrs., 3 crs.

Prerequisite: ENC 1102 with a minimum grade of "C." (Meets Area III Humanities Requirement.) Major writers, literary movements, forms, and themes of literature. This course is a Gordon Rule writing course in which students will produce extensive college-level writing and which requires completion with a minimum grade of "C."

#### **Cultural Sensitivity**

You may encounter controversial issues, language, and discussions during this semester. All controversy must be approached in a sensitive and mature manner. In addition, disrespectful behavior toward another person or body of people will not be tolerated.

#### Goals

The purpose of the course is to foster in students the ability to approach literary works as cultural artifacts from a variety of critical perspectives.

## **Student Learning Outcomes**

- 1. Students will demonstrate knowledge of assigned readings through objective and subjective test materials to be graded by the instructor.
- 2. Students will demonstrate knowledge of assigned readings through written essays to be evaluated according to a rubric for literary analysis.
- 3. Students will demonstrate competency in the use of standard English and MLA style.
