Course Description

ENC1101, English Composition.

Goals

The purpose of the course is to foster in students the writing and critical thinking skills necessary for many college-level classes (and for life beyond the classroom). What distinguishes it from ENC 1102 is that ENC 1101 is an introductory course. Its focus is personal response, analysis, and synthesis.

Student Learning Outcomes

- A. Students will complete at least four major writing assignments. All work submitted to the instructor must be original to this semester and section of this class.
 Work previously submitted for any other class does not fulfill the requirements of this class.
- **B.** Students will write one or more timed, impromptu essays, one of which is the Final Exam. The minimum word count for the final will be 500 words, and the time limit will be two hours. Essays will be evaluated for content and mechanics according to the Rubric for Composition.
- **C.** Students will write two or more major writing assignments of at least 500 words each produced through the process of multiple drafts and revisions that will be written both in and out of class. The composition process may include multiple assignments and deadlines, and the essays will be evaluated for content and mechanics according to the Rubric for Composition.
- **D.** Students will write one multiple-source essay of at least 750 words produced through the process of multiple drafts and revisions that will be written both in and out of class. The composition process may include multiple assignments and deadlines, and the essays will be evaluated for content and mechanics according to the Rubric for Composition.
- **E.** Students will be responsible for other written responses, quizzes, and peer review assignments.
- **F.** Students will write a final exam essay at the time published in the college's official exam schedule. Alternative exam arrangements must be approved by the division chairperson. No student may take the Final Examination without first having submitted all other writing assignments in a **sequential manner** to the course instructor.
- **G.** Students will demonstrate competency in the use of standard English and MLA style by the end of the course.

Student Expectations of the Instructor

Office hours will be held Tuesdays and Thursdays 4:30 pm - 5:30 pm in Rm 102.

I will do my best to respond to voicemails and emails within 24 hours of receipt, excluding weekends.

We will make extensive use of Canvas, a course management program that allows you to turn in your work and take quizzes online, keep track of your grades, communicate easily with me and other students in the class, etc. **You must turn in all assignments on Canvas.**

Expectations of the Student

Academic Integrity

1. Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct is destructive to the spirit of an educational environment and therefore will not be tolerated.

The following definitions will apply:

a. "Cheating" includes but is not limited to use of any unauthorized assistance in taking quizzes, tests or examinations; dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; the acquisition without permission of tests or other academic materials belonging to a member of the College's faculty.

b. "Plagiarism" includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment. It also includes the unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials. It can also include overuse of an editing program like Grammarly or submitting work written by an Artificial Intelligence (AI) generator like ChatGPT. Make certain to consult your course syllabi for your instructors' guidelines on AI material.

c. The term "academic misconduct" includes any or all forms of cheating and plagiarism. In addition, academic misconduct may include the following:

• Destroying, damaging, or stealing another person's work or work materials including, but not limited to, lab experiments, computer programs/files, term papers, projects, or copy of an examination.

• Theft, damage, or misuse of library resources; removing uncharged material from the library; defacing or damaging library materials; intentionally displacing or hoarding library materials within the library for one's unauthorized private use, or any other abuse of reserved materials.

• Theft, damage, or misuse of computer resources including, but not limited to, computer accounts codes, passwords, or facilities; damaging computer equipment or interfering with the operation of any computer system in the college.

2. Individual instructors or programs may provide students with additional academic integrity policy statements at the start of a semester.

3. Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or zero) for the test, assignment, or activity to failure of the course, to suspension, or dismissal from the program or the college.

4. An instructor who believes that an incidence of academic misconduct has occurred will discuss it immediately with the student. If, in the judgment of the instructor, the student has

committed an act of academic misconduct, or if the student admits that there has been misconduct, the instructor will assess the appropriate penalty.

5. Instances of admitted or proven academic misconduct should be reported in writing to the Dean of Student Life. The purpose of this reporting is to track individuals who have repeated incidences. The Vice President of Academic Affairs reserves the right to pursue disciplinary action against a student if deemed necessary.

6. Students who think they have been treated unfairly may invoke the Student Academic Grievance Procedure.

Division Policy on AI-Generated Content

Please note that the use of AI-generated content (such as that produced by ChatGPT) in any of your assignments is strictly prohibited in this class, unless stated otherwise by your instructor. Be aware that overusing virtual editing programs (such as Grammarly) is a form of AI text generation.

The Division of Language and Literature takes academic integrity seriously, and we will be using Turnitin, a plagiarism detection program, to check for any instances of plagiarism or AIgenerated content. Turnitin uses AI content detection to compare student work against a vast database of sources and identify any instances of copied or unoriginal content. If your instructor or Turnitin detects the use of AI-generated content in your work, you may receive a zero on that assignment without the option to revise or resubmit.

Attendance

- 1. Students are expected to attend all classes.
- 2. Upon a student's 5th absence a letter grade will be deducted from the student's final average. After 6 absences, the student will automatically fail the course.
- 3. There are no "excused" absences; however, students who experience extreme circumstances resulting in more than the allowed number of absences may seek mitigation by discussing their circumstances in my office. Verifiable documentation of the circumstances is required. It is up to my discretion as to what constitutes extreme

circumstances.

- 4. Being late to class is disruptive and should be avoided. In this course, two tardies will count as one absence. If you are late to class and we have already begun an in-class response/writing prompt or an in-class quiz, I may ask you to wait outside the classroom until the writing prompt/quiz has concluded. You will not be allowed to make up this assignment.
- 5. If a student leaves class early without my prior consent, that student will receive an absence for the class.

Withdrawals

Students wishing to withdraw must complete a withdrawal form and submit the form to the Office of Enrollment Services before the scheduled withdrawal deadline as published in the college catalog. Student withdrawals initiated prior to the scheduled withdrawal deadline will be recorded as a grade of "W". The withdrawal deadline for an off-term or condensed term is one week after midterm.

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.).

Incompletes

An "Incomplete" ("I") will be considered by the instructor if a student has completed seventyfive percent of the class. This will be determined based on attendance, participation, and/or assignment completion. The instructor may require that the student submit a schedule for completion of the missing work. The "Incomplete" provides 30 days from the ending date of the course to make up any missing work. If work is not submitted during this time period, the grade will automatically change to an "F".
