This section of PHI 2010 is an online class.

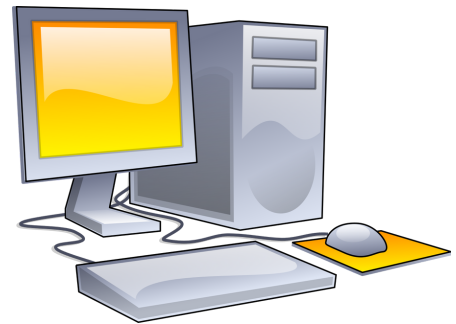
You should have regular and open access to a computer and should maintain reliable internet service.

Now...about the course!

PHI 2010 Course Description: Prerequisite: ENC1101 with a minimum grade of "C." (Meets Philosophy/Religion Humanities requirement.) This is a foundation course in philosophy. Students will learn about topics such as epistemology, metaphysics, and ethics. The course introduces the methods of philosophy, addresses some major philosophical questions, and examines the views of various philosophers from around the world. This course is a Gordon Rule Writing course where students will produce extensive college-level writing and require completion with a minimum grade of "C."

Credit hours: 3

Lecture hours: 3

Student Learning Outcomes

- **Philosophical Thought:** Students will comprehend and analyze various concepts, ideas, and theories in philosophy.
- **Critical Thinking:** Students will develop the ability to evaluate their own and others' philosophical views. Students will learn how to engage with issues through questioning.
- **Cultural Literacy:** Students will develop an appreciation of human culture and its diversity through the comprehension and evaluation of historical and contemporary philosophical problems
- **Social Skills:** Students will develop and use social skills by engaging in

Course Requirements. As a student in this course, you are required to:

- Listen to and take thorough notes on the digital lectures and other resources assigned with each weekly Learning Module;
- Read all of the articles/resources assigned with each Learning Module;
- Contribute to the Discussion Board at least once per week;
- Complete all assignments AS SCHEDULED (see the course schedule below).

Required Textbook:

All necessary resources will be provided by instructor through Canvas at no cost.

You are expected to participate in the course via e-mail exchanges with the instructor, by listening to and taking thorough notes on all digital lectures and other required resources, by reading the assigned readings, by submitting the critical thinking essay, by contributing to the discussion board, by submitting as due additional written assignments, and by completing all exams as scheduled.

Assignment Details

I. Quizzes & Assignments (20%):

There will be weekly quizzes and/or assignments to complete through the course.

They can be found in the Modules. You cannot make them up, but I drop the lowest grade.

II. Argumentative Paper (20%):

You will be required to write a 1200-word argumentative paper.

Details will be provided later in the semester; see schedule for paper workshop and due dates.

III. Reflective Project (10%):

You will be required to develop a reflective project based on your journal entries.

Details will be provided later in the semester. See the schedule for the due date.

IV. Philosophy Journal (10%):

You are required to write 10 weekly journal entries in Canvas. Each of these should be at least 150 words. Prompts will be given each week via Canvas. Points will be taken off if you do not reach the word count.

• Midterm Exam (15%):

Instructor Policies

Attendance Policy: Although physical class meetings are not part of this course, participation in all interactive learning activities each week is required. It is required that you are present and active each week in the course and complete assignments by their scheduled due dates.

Make-Up Work Policy: Late work should be the exception and not the norm. Missing any of the scheduled work may prevent completion of the course. If you foresee difficulty of any type (e.g., an illness, employment change, etc.) that may prevent completion of this course, notify the instructor as soon as possible. Failure to do so may result in failure for an assignment and/or failure of the course.

Late work will be accepted up to the point where a 0 grade would be earned or until the late work deadline at the end of the term (posted in the schedule), whichever comes first. A late penalty of 10% per week late will be assessed regardless of the reason for the late work. Exceptions to the late penalty may be made in extraordinary circumstances (such as hospitalization). Computer/technology problems do not constitute extraordinary circumstances because access to proper technology is required for this online class.

Academic Integrity Policy - Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct, including cheating or plagiarism, is destructive to the spirit of an educational environment. Social Science professors report every instance of student academic misconduct to the college for inclusion on the student's records. "Cheating" includes but is not limited to use of any unauthorized assistance in completing course work.

"Plagiarism" includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment as well as the purchase of papers or projects. "Self-plagiarism" occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class. Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

Attendance - Regular class attendance and participation are significant factors that help to promote success in college. In face-to-face courses, students are required to be in class at the beginning of each class session, as attendance will be taken at this time. If a student arrives late, it is his/her responsibility to inform the instructor after class of his/her presence. Failure to do so may result in the student being marked as "Absent." Attendance in an online/hybrid CANVAS class is defined as the submission of complete written assignments prior to their posted deadline.

Withdrawals - Students may withdraw themselves from any course until the published withdrawal deadline for that term in the Gulf Coast State College catalog. Students wishing to withdraw from a course and receive a "W" must complete a withdrawal form and submit this to the Office of Enrollment Services prior to the scheduled withdrawal date as published on the college calendar. If you feel you have a unique situation that warrants removal from all of your courses for a term after the withdrawal deadline has passed, you may contact the Vice President of Student Affairs to discuss

Consequences of Withdrawals - Two withdrawals are permitted per credit course; after that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.).

Incomplete Grades - Grades of Incomplete in any Social Sciences course can be assigned only to students who have an emergency arise during the last two weeks of the course.

To receive an Incomplete, students must:

- Submit a written request to the instructor prior to the last face-to-face class meeting. For online courses, the Incomplete request must be received no later than the week before the Final Exam period begins.
- Have completed no less than 60 percent of the course requirements and be passing the course at the time the request for an Incomplete is submitted.

Important Note: The Incomplete option provides 30 days from the date grades are due to make up any missing work; if work is not submitted during this period, the grade will automatically change to an “F” in Lighthouse.
