PSY2012 Catalog/Course Description and Broad Goals:

- In this course, students will gain an introduction to the scientific study of human behavior and mental processes. Topics may be drawn from historical and current perspectives in psychology.
- This course is primarily reading-based, with opportunities for discussions via the Canvas Discussion Board.
- The broad goals of the course include students learning and retaining a significant amount of information on human behaviors; mental disturbances using the principles of the major paradigms; Categorize and evaluate the stages of human development; demonstrate a general knowledge of the concepts of memory and cognition; develop critical thinking and deductive reasoning skills; and improving communication skills.

STUDENT LEARNING OUTCOMES:

Upon successful completion of PSY2012, students will be able to:

- 1. Identify basic psychological theories, terms, and principles from historical and current perspectives.
- 2. Recognize real-world applications of psychological theories, terms, and principles.
- 3. Recognize basic strategies used in psychological research.
- 4. Draw logical conclusions about behavior and mental processes based on empirical evidence.

Student Learning Objectives

1. Categorize the various approaches, fields, and subfields of psychology along with their major concepts and important figures in these domains.

2. Identify preeminent theories, principles, and research findings, and give examples of psychology's integrative perspectives and concepts by applying them to everyday life.

3. Demonstrate an understanding of psychological theories regarding the relationship between physiology, cognition, and emotion.

4. Explain how humans become self-aware, how we learn to interact with others, how we influence others, and how they influence us.

5. Classify the strategies with which psychologists study human behavior and how this knowledge is used to explain, predict, and influence behavior.

Expectations Statement:

The student is expected to participate in the course via e-mail exchanges with the instructor, by listening to and taking thorough notes on all digital lectures, reading the assigned readings, contributing to the Discussion Board, completing all Exams, Assignments, Course Feedback, Student Therapy Project, and Final Exam as scheduled.

- Students enrolled in this section of PSY 2012 are expected to use Canvas, the OpenStax textbook website, and their GCSC email address for accessing the learning materials for this course and for all internet-based communication.
- Students enrolled in this course must have access to a personal computer or Laptop with working internet service to be successful. Students must download the Respondus Lockdown browser for testing purposes for the course. Google Chromebooks have not been compatible with Canvas; students should be prepared to use a personal computer.
- The primary learning activities in this course will be watching and taking thorough notes on each of the lectures, reading all the assigned pages within the textbook, and contributing to our ongoing discussion boards, research component, and course feedback.
