**Course Description:** Understanding Visual Arts is a general introduction to the study and appreciation of visual art. This course will address the role of art in society, familiarize the student with the elements of art and principles of design, introduce the use of various media, and provide a brief chronological history of visual art.

**Course Content Delivery:** Lectures, class discussions, art projects, and attendance of three art events.

**Broad Goals of the Course:** In this course, students will develop an appreciation of and the ability to think critically about culture and be provided with the tools to understand, analyze, and discuss works of visual art and material culture.

- 4. Students will analyze works of visual art and material culture in the works' cultural context, including works from or inspired by the Western canon and other cultural traditions.
- 5. Students will generate an analytical response to works of visual art and material culture in the works' cultural context.
