Now...about the course!

Prerequisite: ENC1101 with a minimum grade of "C." (Meets Philosophy/Religion Humanities requirement.)

Students in this course will be introduced to the nature of philosophy, philosophical thinking, major intellectual movements in the history of philosophy, including topics from the western philosophical tradition, and various problems in philosophy. Students will strengthen their intellectual skills, become more effective learners, and develop broad foundational knowledge. PHI 2010 requires that students produce extensive college-level writing and complete the course with a minimum grade of "C."

Student Learning Outcomes

- Develop critical thinking skills.
- Demonstrate an understanding of classical western philosophical views
- Analyze, explain, and evaluate foundational concepts of epistemology, metaphysics, and ethics.

Course Requirements. As a student in this course, you are required to:

- Listen to and take thorough notes on the digital lectures and other resources assigned with each weekly Learning Module;
- Read all of the textbook chapters assigned with each Learning Module;
- Contribute to the Discussion Board in scheduled weeks;
- Complete all assignments AS SCHEDULED (see the course schedule below).
- Contact the instructor via email at once with any problems or issues. I cannot help you if I don't know what you are struggling with.

Required Textbook:

No Required Textbook. Materials provided in the Canvas classroom.

Student Expectation Statement:

You are expected to participate in the course via e-mail exchanges with the instructor, by listening to and taking thorough notes on all digital lectures and other required resources, by reading the assigned readings, by submitting the critical thinking essay, by contributing to the discussion board, by submitting as due additional written assignments, and by completing all exams as scheduled.

Method of Evaluation:

Assignment Details and Assessment

I. Discussion Forum (20%):

Discussion forum assignments are scheduled throughout the course. In the weeks in which a discussion forum is assigned--unless otherwise stated in Canvas-- your first discussion forum response is due Wednesday by 11:59 pm; remaining posts can take place at your own pace provided they are posted by Sunday 11:59 pm.

Points are awarded based on the number and quality of posts. All posts should add substantively to our discussion and generate further discussion and additional in-depth analysis. All posts must be at least 150 words in length and include supporting citations referencing the digital lectures, readings or other assigned resources.

II. Critical Thinking Activities/Assignments (30%):

Each week you are required to watch the week's recorded lecture, view the other assigned resources, and submit assignments designed to reinforce the week's learnings and check comprehension. Six of these weekly assignments will be "critical thinking" activities. These activities will vary from week to week and include short writing assignments, worksheets, and research assignments.

III. Critical Thinking Essay (20%):

One 1,500-word critical thinking and reflection essay is required. The essay format and content instructions are posted in Canvas, both in the Welcome module and in the weekly module in which the essay is due.

When the essay is submitted to the drop box, it will automatically undergo a **TurnItIn review for plagiarism**, intentional or unintentional. Your essay is not considered submitted until you have verified your TurnItIn score is 20% or less. Scores that are too high put you at risk for violating the Academic Integrity policy.

IV. Quizzes and Exams (30%):

Three quizzes/exams, including the final exam, will be given during the semester. The quizzes are multiple choice, true/false and short answer. The semester will end with a comprehensive final exam that is multiple choice/true false. All quizzes and the final exam will be given through Canvas. There is no need to come to campus for testing unless you choose to.

Instructor Policies

Attendance Policy: Although physical class meetings are not part of this course, participation in all interactive learning activities each week is required. It is required that you are present and active each week in the course and complete assignments by their scheduled due dates.

Make-Up Work Policy: Late work should be the exception and not the norm. Missing any of the scheduled work may prevent completion of the course. If you foresee difficulty of any type (e.g., an illness, employment change, etc.) that may prevent completion of this course, notify the instructor as soon as possible. Failure to do so may result in failure for an assignment and/or failure of the course.

Late work will be accepted up to the point where a 0 grade would be earned or until the late work deadline at the end of the term (posted in the schedule), whichever comes first. A late penalty of 10% per week late will be assessed regardless of the reason for the late work. Exceptions to the late penalty may be made in extraordinary circumstances (such as hospitalization). Computer/technology problems do not constitute extraordinary circumstances because access to proper technology is required for this online class.

Social Sciences Policies

<u>Academic Integrity Policy</u> - Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct, including cheating or plagiarism, is destructive to the spirit of an educational environment. - "Cheating" includes but is not limited to the use of any unauthorized assistance in completing coursework.
- "Plagiarism" includes, but is not limited to, the use by paraphrase or direct quotation of another person's published or unpublished work without full and clear acknowledgment as well as the purchase of papers or projects.
- **"Self-plagiarism**" occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class.
- The use of Al software in any form to create class assignments may violate GCSC's Academic Integrity Policy. Before employing Al technology in any manner and to any degree, students should consult with their professors for all courses offered through the Social Sciences Division.

Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

<u>Email & Voicemail Response Time</u> - Instructors will check and respond to messages sent to their gulfcoast.edu email within 48 hours during scheduled workdays, barring illness or emergencies. The instructor may or may not check email during holidays or weekends. This policy also applies to messages sent via Canvas, as well as voicemails left on a provided phone number.

<u>Attendance</u> - Regular class attendance and participation are significant factors that help to promote success in college. In face-to-face courses, students are required to be in class at the beginning of each class session, as attendance will be taken at this time. If a student arrives late, it is his/her responsibility to inform the instructor after class of his/her presence. Failure to do so may result in the student being marked as "Absent." Attendance in an online/hybrid CANVAS class is defined as the submission of complete written assignments before their posted deadline.

<u>Withdrawals</u> - Students may withdraw themselves from any course until the published withdrawal deadline for that term in the Gulf Coast State College catalog. Students wishing to withdraw from a course and receive a "W" must complete a withdrawal form and submit this to the Office of Enrollment Services before the scheduled withdrawal date as published on the college calendar. If you feel you have a unique situation that warrants removal from all of your courses for a term after the withdrawal deadline has passed, you may contact the Vice President of Student Affairs to discuss your situation.

<u>Consequences of Withdrawals</u> - Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.).

<u>Incomplete Grades</u> - Grades of Incomplete in any Social Sciences course can only be assigned to students who have an emergency arise during the last two weeks of the course.

To receive an Incomplete, students must:

- Submit a written request to the instructor before the last face-to-face class meeting. For online courses, a written Incomplete request must be received no later than the week before the Final Exam period begins.
- Have completed no less than 60 percent of the course requirements and be passing the course at the time the request for an Incomplete is submitted.

Important Note: The Incomplete option provides 30 days from the date grades are due to make up any missing work; if work is not submitted during this period, the grade will automatically change to an "F" in Lighthouse.
