**Technology Requirements for this Course:** This course requires students to have access to a computer and the Internet. For those students who do not own a computer, computer labs are available on the GCSC campus and in public libraries. Students without internet access can come to the GCSC campus, go to local public libraries or coffee shops, etc.

**Catalog Description:** In this course students will investigate how the national government is structured and how the American constitutional republic operates. It covers the philosophical and historical foundations of American government, including but not limited to: the Declaration of Independence, the US Constitution and its amendments, and The Federalist Papers. The course examines the branches of government and the government's laws, policies, and programs. It also examines the ways in which citizens participate in their government and ways their government responds to citizens.

**Teaching Techniques:** The means of content delivery for this course include instructor-generated lectures, textbook readings, PowerPoint presentations, discussion board contributions, one-on-one correspondence, online videos, and supplementary websites. Each of these techniques supports the broad goals of students learning the American political system in its most broad aspects and understanding the functions, processes, policies, and philosophical foundations of that system.

#### **Student Learning Outcomes (SLOs):**

- Students will demonstrate an understanding of the basic principles and practices of America's constitutional republic.
- Students will demonstrate knowledge of the nation's founding documents, including the Declaration of Independence, the US Constitution and its amendments, and *The Federalist Papers*.
- Students will demonstrate knowledge of landmark US Supreme Court cases, landmark legislation, and landmark executive actions.
- Students will demonstrate knowledge of the history and development of the American federal government and its impact on law and society.
- Students will demonstrate an ability to apply course material to contemporary political issues and debates.
- Students will demonstrate an ability to engage in discussion and civil debate on American politics that are associated with multiple points of view.

- Contribute to the Discussion Board prompts, when assigned.
- Complete all three Unit Exams AS SCHEDULED (see the course schedule below).
- Contact the instructor via email or Canvas at once with any problems or issues. I cannot handle problems unless you make me aware of them.

**Instructor Policies and General Information:** You should be mindful of how you communicate with the instructor for this course. Proofread your messages before sending them, and always be respectful. Before sending your instructor a message, check to make sure your concern has not already been addressed in a Canvas course announcement, a Canvas message to the class, or this syllabus.

**Attendance Policy:** A student's acquisition of learning outcomes is tied to attendance. Excessive absences guarantee that a student has not had minimal exposure to enough of the student learning outcomes to receive credit for the course. As such, missing multiple class periods will likely lead to failure.

For an online course, attendance is measured by assignment submissions. To be counted as present for the week's classes, students must submit at least one of the week's assignments. The only way to be successful in this course is to keep up with all the assigned readings, coursework, and to complete the weekly assignments.

Make-Up Work Policy: Students should be forewarned that my policies on missed and late work in this class are strict and rigid. With very few exceptions, I will not accept any late work in this course. Please acquaint yourself with the assignment deadlines now and prepare ahead to ensure that you do not miss any assignments or assignment deadlines.

Listed below are the exceptions to this course's no-tolerance late policy:

Students should promptly contact me when any unforeseen, legitimate circumstance beyond his/her control (i.e., things that do not involve a choice, like documented illness or medical emergency; family funeral; or athletic travel) occurs that may result in a missed assignment deadline. Students who foresee missing assignment deadlines due to voluntary travel or other circumstances within the student's control should submit work early.

Likewise, note that a lack of access to internet services is not a valid excuse for missing or late work. As an online student, it is your responsibility to figure out a way to submit your work. The library on campus is open after hours and there are many public spaces with free Wi-Fi (your public library, Panera, McDonald's, etc.). Take advantage of the Canvas app and other services on your phone as well, if possible.

<u>Withdrawals</u> - Students may withdraw themselves from any course until the published withdrawal deadline for that term in the Gulf Coast State College catalog. <u>Consequences of Withdrawals</u> - Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. <u>Incomplete Grades</u> - Grades of Incomplete in any Social Sciences course can only be assigned to students who have an emergency arise during the last two weeks of the course.

#### To receive an Incomplete, students must:

- Submit a written request to the instructor prior to the last face-to-face class meeting. For online
  courses, a written Incomplete request must be received no later than the week before the Final
  Exam period begins.
- Have completed no less than 60 percent of the course requirements and be passing the course at the time the request for an Incomplete is submitted.

**Important Note**: The Incomplete option provides 30 days from the date grades are due to make up any missing work; if work is not submitted during this period, the grade will automatically change to an "F" in Lighthouse.
