### Course Information

#### Catalog Description:

An introduction to financial accounting. The complete accounting cycle will be studied as it relates to a service business and a merchandising business. Additional topics include financial reporting and analysis, short-term liquid assets, and internal control.

1. Demonstrate the ability to prepare financial statements
2. Demonstrate the ability to analyze and record accounting transactions
3. Demonstrate the ability to record adjusting journal entries
4. Demonstrate the ability to prepare a trial balance

5. Demonstrate the ability to complete the closing process
6. Demonstrate the ability to record the journal entries related to merchandising activities
7. Demonstrate the ability to determine the value of merchandise inventories and cost of sales using FIFO, LIFO, Specific ID, and Weighted Average
8. Demonstrate the ability to identify the different steps in the accounting cycle

### Homework & Quizzes

Homework & quizzes can be accessed in Canvas through WileyPLUS. WileyPLUS is a web-based assignment and assessment solution required for this course. As outlined in this syllabus, these assignments will make up a significant portion of your overall course grade. Late assignments will NOT be accepted. It is the student's responsibility to keep up with class assignments online despite unattended classes. Considerable time outside of class will be required to complete course assignments. You should allow an average of two hours outside of class for every one hour in class to complete assignments, study, and prepare. In-class participation assignments may be given and will reflect within your homework grade. In-class participation assignments cannot be made-up.

### Exams

All exams will be taken on campus for this course. Exceptions needed for excused exam absences (with documentation) will be assessed on a case-by-case basis. Scientific or basic four-function calculators are

permitted for exams, but programmable calculators are NOT permitted for use on exams (this includes graphing calculators, such as the TI-84 or TI-89). The use of notes, textbook (or Wiley Course resources), other websites, or other students work during an exam is strictly prohibited. The penalty for engaging in use in unauthorized resources or assistance on an exam will result in an automatic score of zero on the exam, as well as Academic Integrity Violation report being submitted and connected to the student for the remainder of their academic career.

### Withdrawal Policy

**The last day for students to cancel registration/drop courses and receive a refund is August 21, 2026 (by 11:59pm).** Additionally, students may initiate their own withdraw from the course through the Office of Enrollment Services up to the **withdrawal deadline of October 14, 2026.** Refunds are not issued for course withdrawals. After the withdrawal deadline, the instructor must assign a grade.

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.). There are two kinds of withdrawals---student and administrative.

- *Student Withdrawal (W1)* - Students wishing to withdraw must complete the online Student Withdrawal Form before the scheduled withdrawal deadline as published in the College catalog. Student withdrawals initiated prior to the scheduled withdrawal deadline will be recorded as a

grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.

- *Administrative Withdrawal (W2)* – A faculty member may withdraw a student up to the published withdrawal deadline for violation of the class attendance policy in which case the student will receive a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.

Students cannot withdraw from developmental studies courses (college-preparatory classes) after the drop/add period without written permission from their instructor and/or their academic advisor.

## Academic Integrity

Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct, including cheating or plagiarism, is destructive to the spirit of an educational environment. The following definitions will apply:

"Cheating"

includes but is not limited to use of any unauthorized assistance in taking quizzes, tests, or examinations; dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; the acquisition without permission of tests or other academic materials belonging to a member of the College's faculty.

"Plagiarism"

includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment as well as the purchase of papers or projects. It can also include overuse of an editing program like Grammarly or submitting work written by an Artificial Intelligence (AI) generator like ChatGPT. Make certain to consult your course syllabi for your instructor's guidelines of AI material.

"Self-plagiarism"

occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class.

"Generative Artificial Intelligence (AI)"

is technology that uses machine learning to create new content, such as text, images or code, based on user input. These systems are trained on vast amounts of data, including large language models and image or code generators. Common examples include ChatGPT, GitHub, Copilot, Google Gemini, Perplexity, and the Grammarly AI function.

Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

## Classroom Recording

In accordance with federal and state privacy laws, students may record class lectures for their own personal educational use, in connection with a complaint to the college, or as evidence in internal or external legal proceedings. Students may not publish or upload the recordings or any components thereof without the knowledge and written permission of the faculty member. Representing work created by AI as one's own is a violation of academic integrity and may result in penalties, including a zero on the assignment and additional disciplinary actions as outlined in the college's academic integrity policy.*

**In ACG2001, students may NOT use generative AI to calculate answers and/or responses for graded assignments.**
