## Course Information

### Catalog Description:

Understanding Visual Arts is a general introduction to the study and appreciation of visual art. This course will address the role of art in society, familiarize the student with the elements and principles of design, introduce the use of various media, and provide a brief chronological history of visual art.

### Student Learning Outcomes:

In this course, students will develop an appreciation of and the ability to think critically about culture and be provided with the tools to understand, analyze, and discuss works of visual art and material culture.

### Student Learning Outcomes:

1. Students will identify and describe terms, concepts, and methods used in the discipline of art history.
2. Students will apply terms, concepts, and methods used in the discipline of art history to works of visual art and material culture.
3. Students will identify and describe works of visual art and material culture in the works' cultural context, including works from or inspired by the Western canon and other cultural traditions.
4. Students will analyze works of visual art and material culture in the works' cultural context, including works from or inspired by the Western canon and other cultural traditions.
5. Students will generate an analytical response to works of visual art and material culture in the works' cultural context.

This course meets face to face. Course material, assignments, and announcements may be offered via Canvas as a supplemental approach to learning at the discretion of the instructor. **Connect:** In this course, we will be using a program called Connect. You will access this book in Canvas and instructions are provided in the [Ebook](#).

Connect is an online assignment and assessment software created by the publisher of your textbook, McGraw Hill. It has many innovative features to help you better learn, analyze, and retain information offered in this course. One of its key features used in the class is the Smart Book. Smart Book is an electronic version of your text, which adjusts to your individual style of learning. As you read each chapter, you'll be asked a series of questions. These questions are then used to gauge your understanding of the material and to alter future readings to highlight areas of the text where you need the most help. Connect-based assignments will account for 45% of your overall grade. You may purchase access to Connect from the bookstore as a stand-alone, or as a package deal with the hard copy of the textbook. You may also purchase the access code directly from the publisher.

**Please understand that when you buy access to Connect you are also getting access to the electronic version of the text, so unless you also want a hard copy of the textbook you do not need to buy it.**

**Remember:** This course is not one in which students may work at their own pace. Each week there are learning modules, assignments, and/or online exams with due dates. Refer to the schedule within this syllabus and within Canvas for more information.

## Grading

### Calculation of Grades

You are expected to spend at least **2 - 3 hours per week** reading, studying, and working on studio projects.

### Method of Evaluation

Assignments will be assessed and then given points according to how well they meet the requirements in the explanation and written guidelines. End-of-semester grades will be awarded on the following percentage basis.

The final class grade will be based on the following factors:

- Readings: 20%
- Quizzes: 25%
- Projects 25%
- Events: 5%
- Exams: 25%

### **Weekly Reading 20% and Quizzes 25%**

Each week, you will be assigned readings from the textbook. These readings must be completed using the Connect Smart Book, an online E-book learning tool designed to help with comprehension and retention. Once you log in to Connect, you'll see a tutorial on how to use it. Each reading is connected to a weekly Quiz. You must complete all readings for that week and demonstrate a 90% comprehension level before the weekly quiz becomes available. The readings must be done using the Smart Book in order to demonstrate proficiency. I understand that some of you may prefer to read from an actual textbook. You may do that, but you'll still have to complete the Practice section of your Smart Book to demonstrate proficiency and receive a grade. There are only two grade options for the readings – 100% or 0%. To receive 100%, you must complete all assigned readings for that week; anything less will result in a grade of 0%.

**Remember, the only way to gain access to the weekly Quiz is to demonstrate 90% proficiency.** All readings/quizzes are due on Sunday by 11 pm, so make sure to leave yourself enough time to complete the assignment. **Late assignments will not be accepted and will receive zero (0) points.**

### **Grades for Reading & Quizzes**

Connect will automatically update your reading & quiz grades in Canvas.

### **Projects 25%**

Projects will be assigned on a semi-regular basis (2 will be assigned in total). These will both be hands-on projects. All of the projects will be submitted by clicking the Submit Assignment button by the assigned due date. Late projects will not be accepted and will receive zero (0) points. Some of your Projects will require the submission of digital images, so you will need access to a scanner (a scanner app on your phone will also work) and/or a digital camera like the one on your phone. If you do not have a scanner, there are some available at the library, or you can have it scanned for you at various commercial locations (Kinko's, Office Max, etc.). All Projects will be assigned on Canvas and will show up before they are due.

### **Feedback on Projects**

I will post grades and comments on Projects within a week of the due date. Not all posts will receive comments. To view the comments, you must click on the Grades tab, then click on the text box icon located on the far-right end of the column with the assignment you want to review. You can also access comments by clicking on the assignment and then clicking on the Submission Details link.

Time frame: My goal is to post grades and feedback up to one week after the assignment deadline.

### **GCSC Event Attendance 5%**

Over the course of the semester, you are required to attend two (2) GCSC art events, such as art show openings, artist lectures, and artist demonstrations. I strongly suggest planning ahead to make sure that you are able to attend these. If, for some reason, you

can't, you can make up the points by completing extra credit (see below). While we have great theater and music programming, which you should attend if you get a chance, only visual art events count toward your Event grade. To verify attendance, the student will be asked to take a selfie at the event with their favorite work of art and upload this to the EVENT Assignment. All eligible events will be listed on the calendar and may also be found on the Events page found under the Modules tab.

### **Extra Credit**

GCSC will host a number of "Visual Arts Events" over the course of the semester. The events are listed on the calendar and may also be found on the Event page found under the Modules tab (Events). To receive extra credit, you must attend an event/gallery and write a brief review (300-350 words) of the show you have attended. The review should be based on the material you have learned in class. For example, you may talk about what "Theme of Art" a particular work fits into, and why. You may also approach the work from a formal standpoint and talk about composition, elements of design, media, etc. Another approach may be comparing the work to another work from art history. Your review may include the whole show, a couple of pieces, or just one piece that really grabbed your attention. (Please attach pictures of the work that you are describing.) Upload your paper and images. Successful completion of this assignment will add 100 points to your overall grade as part of Event Attendance. You may complete a maximum of three (3) extra credit assignments over the course of the semester for a total of 300 extra Event Attendance points. If you live far outside of Panama City or found an event at an off-campus venue, you may submit a review of that event for extra credit. All events must be Visual Arts events.

### **Exams 25%**

These will be timed exams limited to ninety (90) minutes. The exams will be given in person during a designated class period. In case of extreme circumstances, the student may arrange to take the exam at a different time, only if that arrangement is made by Friday before the assigned exam date. The best way to prepare for exams is by regularly completing the weekly readings, taking the time to learn from your weekly quizzes, and regularly taking notes and highlighting key concepts in your text. There will be three tests given this term.

Instructors will monitor attendance at the beginning of each semester. If you are not in attendance during this period, you may be withdrawn from the course. You will be financially responsible for the course and a "W or NS" will appear on your transcript. Withdrawal from a course may also have implications for financial aid.

## Withdrawal Policy

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.). There are two kinds of withdrawals---student and administrative.

- *Student Withdrawal (W1)* - Students wishing to withdraw must complete the online Student Withdrawal Form before the scheduled withdrawal deadline as published in the College catalog. Student withdrawals initiated prior to the scheduled withdrawal deadline will be recorded as a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.
- *Administrative Withdrawal (W2)* – A faculty member may withdraw a student up to the published withdrawal deadline for violation of the class attendance policy in which case the student will receive a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.

Students cannot withdraw from developmental studies courses (college-preparatory classes) after the drop/add period without written permission from their instructor and/or their academic advisor.

## Academic Integrity

Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct, including cheating or plagiarism, is destructive to the spirit of an educational environment. The following definitions will apply:

### "Cheating"

includes but is not limited to use of any unauthorized assistance in taking quizzes, tests, or examinations; dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; the acquisition without permission of tests or other academic materials belonging to a member of the College's faculty.

### "Plagiarism"

includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment as well as the purchase of papers or projects. It can also include overuse of an editing program like Grammarly or submitting work written by an Artificial Intelligence (AI) generator like ChatGPT. Make certain to consult your course syllabi for your instructor's guidelines of AI material.

### "Self-plagiarism"

occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class.

### "Generative Artificial Intelligence (AI)"

is technology that uses machine learning to create new content, such as text, images or code, based on user input. These systems are trained on vast amounts of data, including large language models and image or code generators. Common examples include ChatGPT, GitHub, Copilot, Google Gemini, Perplexity, and the Grammarly AI function.

Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

### Classroom Recording

In accordance with federal and state privacy laws, students may record class lectures for their own personal educational use, in connection with a complaint to the college, or as evidence in internal or external legal proceedings. Students may not publish or upload the recordings or any components thereof without the knowledge and written permission of the faculty member. #### Limited Assistive Use Only

*Students may use basic assistive technologies for spelling, grammar, and formatting (e.g., PaperRater or SpellCheckPLUS); however, the use of AI tools (e.g., ChatGPT, Copilot, Grammarly's AI function, etc.) for generating, rewriting, or enhancing content is not permitted. All work must reflect the student's original ideas and writing. Representing work created by AI as one's own is a violation of academic integrity and may result in penalties, including a zero on the assignment and additional disciplinary actions as outlined in the college's academic integrity policy.*

Use of ChatGPT or any other generative AI software is strictly prohibited for any and all assignments submitted for this class. It will rest on you, as the student, to prove you have not used any generative AI software should your writing flag suspicion. To avoid any back and forth on this, please use either Google Docs or Apple's Pages with "tracking" turned on, or "Track Changes" in Word. This makes it very easy for you to prove your work is your own, should any questions arise.

**\*There is robust software available to detect all AI-generated content. If your submission is identified as being AI-generated and you cannot show any documentation to prove otherwise, it will automatically receive a 0% grade. If you choose to dispute this ruling, you will be asked to provide an in-person writing sample in the testing center. With a second offense, you will be referred to the Dean of Student Affairs for further disciplinary measures. These measures may include expulsion from the class and, for repeat offenders, the college.\***
