## Course Information

### Catalog Description:

(Offered fall, spring, and summer). Prerequisite: Math placement test or minimum grade of "C" in MAT1033. In this course, students will develop problem-solving skills, critical thinking, computational proficiency, and contextual fluency through the study of equations, functions, and their graphs. Emphasis will be placed on quadratic equations, exponential, and logarithmic functions. Topics will include solving equations and inequalities, definition and properties of a function, domain and range, transformations of graphs, operations on functions, composite and

inverse functions, basic polynomial and rational functions, exponential and logarithmic functions, and applications. A graphing calculator is required. The TI-83/84 are the only allowable calculators for test days. If a student wishes to use any other calculator, they must see their instructor in advance for approval. This online class requires proctored exams which can be taken for free at any GCSC campus, with ProctorU which has a fee, or an approved proctor. Please see testing services for all available options.

### Student Learning Outcomes:

#### The student will:

1. Solve an equation or an inequality using an appropriate technique.
2. Define and describe functions, their properties, and graphs.
3. Manipulate functions to simplify expressions and find new functions.
4. Use transformations to write an equation for a function and to graph a function.
5. Model and solve real-world problems using functions.

### Course Materials & Resources:

**Graphing Calculator:** A graphing calculator is required (TI-83 or TI-84). The problems in the text, software, and course videos are illustrated using the TI-84+. Students are expected to have their own calculators. If a student wishes to use any other calculator, they must see their instructor in advance for approval.

### Delivery Method:

This method requires students to complete the course on their own with proctored examinations. Rather than attending live lectures, students will view online course videos. There are no class meetings. Students obtain course information, including test times and procedures, that can be viewed on the Canvas LMS. Students are required to take proctored unit tests and a final exam at the dates specified either at the GCSC campus testing center, ProctorU, or with an approved proctor at a designated remote area. Students will study the E-textbook and work on the practice and homework problems in MyMathLab. The College Algebra Study Guide and course videos are available on the Canvas LMS. Students should check Canvas daily for e-mails and announcements. Your MyMathLab code is good for 18 weeks.

### Student Expectations

In this course, communication and feedback will occur through various channels, including GCSC email, Canvas Inbox, Canvas Announcements, Canvas Discussions, Microsoft Teams or Zoom, assignment feedback, and instructor office hours. ## Course Schedule

The semester is divided into 5 units. The contents of each unit are referenced by textbook sections below. Typically, two to three sections will be covered per week. For each section, students will be assigned graded homework and quiz assignments in MyLab. You are allowed to repeat each quiz and homework before the deadline multiple times and the highest score is kept. There will be unit test reviews that will give you a good indication of how you will do on the tests in MyLab Math. There is also a final exam review. There will be five-unit tests and a final exam in MyLab Math. The unit tests will be announced in advance, and will count equally. There are **no exemptions** from the final exam.

A detailed daily schedule, which includes testing dates and a list of assigned homework problems, will be provided to students on the first day of class.

## Grading

### GCSC Grading Scale

A (100-90), B (89-80), C (79-70), D (69-60), and F (59-0).

### Calculation of Grades

1. The average of the five-unit tests will count 50% of your grade. The quizzes will count 10%, homework will each count 15%, and reviews for tests will count 0% of your grade. A comprehensive final exam (no exemptions) will count 25% of your grade. The college grading scale will be used to convert the numerical average to a letter grade. The GCSC grading scale is: A (100-90), B (89-80), C (79-70), D (69-60), and F (59-0).
2. At the discretion of the instructor, the final exam score can substitute for the lowest unit test grade, if that substitution improves the student's final average.

3. Mathematics Division policies allow no take-home tests, no extra credit assignments, and no curving of grades.
4. Students will not be allowed to leave a testing situation (such as a unit test, midterm, or final exam) and come back at a later time to finish the test.
5. Students will not be allowed to retake a unit test, midterm, or final exam.

Instructors will monitor assignment submission at the beginning of each semester. If you submit no assignments during this period, you may be withdrawn from the course. You will be financially responsible for the course and a "W" or "NS" will appear on your transcript. Withdrawal from a course may also have implications for financial aid.

### Make-Up Work Policy

- **NO** Extra credit
- **SOME** out of class assignment grades may be dropped at the discretion of the instructor.
- Out of class assignments are due by the date your instructor sets. It is your responsibility to know and adhere to the due dates.
- **NO** retakes of any tests.
- **NO** test grades will be dropped.
- The Schedule set forth outlines what is covered and what the deadlines are. You know in advance the testing dates for each test; therefore, missing a test is unacceptable and you will receive a grade of zero for that missed test without a make-up. However, if missing a test is unavoidable, then you require prior approval.
- If a test is missed due to a valid excuse and is granted, then a make-up test will need to occur as per agreement with your instructor. Proof of why you missed test will be required, and it is the student's responsibility to make necessary arrangements to contact their instructor regarding a make-up test.
- The final exam can be used to replace the lowest unit test grade, if it helps improve your grade.

- Missed test grades (grades of zero) will not be replaced.

## Withdrawal Policy

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.). There are two kinds of withdrawals---student and administrative.

- *Student Withdrawal (W1)* - Students wishing to withdraw must complete the online Student Withdrawal Form before the scheduled withdrawal deadline as published in the College catalog. Student withdrawals initiated prior to the scheduled withdrawal deadline will be recorded as a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.
- *Administrative Withdrawal (W2)* – A faculty member may withdraw a student up to the published withdrawal deadline for violation of the class attendance policy in which case the student will receive a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.

### "Cheating"

includes but is not limited to use of any unauthorized assistance in taking quizzes, tests, or examinations; dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; the acquisition without permission of tests or other academic materials belonging to a member of the College's faculty.

### "Plagiarism"

includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment as well as the purchase of papers or projects. It can also include overuse of an editing program like Grammarly or submitting work written by an Artificial Intelligence (AI) generator like ChatGPT. Make certain to consult your course syllabi for your instructor's guidelines of AI material.

### "Self-plagiarism"

occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class.

### "Generative Artificial Intelligence (AI)"

is technology that uses machine learning to create new content, such as text, images or code, based on user input. These systems are trained on vast amounts of data, including large language models and image or code generators. Common examples include ChatGPT, GitHub, Copilot, Google Gemini, Perplexity, and the Grammarly AI function.

Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

## Classroom Recording

In accordance with federal and state privacy laws, students may record class lectures for their own personal educational use, in connection with a complaint to the college, or as evidence in internal or external legal proceedings. The Math Division at GCSC discourages you from utilizing AI as a substantial source of your learning. You are expected to do your own work in this course and will be graded on your mastery of the material herein. Although AI can be an outside resource for problem solving, it may not be a reliable source. What is most important in a math course is that you personally learn the step-by-step processes that it

takes to find solutions to problems, to analyze data sets, to create mathematical models, and to apply what you have learned, in theory or through formulas, to applications of mathematics found in real-life instances.

For graded assignments (tests, quizzes, or otherwise), you will not be allowed to use any AI tools, such as chatbots, text generators, paraphrasers, summarizers or solvers, to complete any part of your assignments. Using AI tools for graded assignments will be considered a form of academic dishonesty and could result in a grade of zero for the assignment and disciplinary action. If you have any questions about what constitutes acceptable uses of AI tools, inside or outside the classroom, please consult your instructor.
