Course Information

Catalog Description:

Early intermediate class instruction in piano techniques, keyboard harmony, and basic musicianship skills. Emphasis is placed on the foundations of technique, rudiments of keyboard theory, and accompaniment principles. Offered in Spring semester.

Student Learning Outcomes:

The broad objective of Class Piano II is the continued development of necessary keyboard skills for students to function as competent and confident musicians. Skills introduced will include the categories of harmonization, transposition, improvisation, sight reading, repertoire, improvisation, and keyboard theory. These topics are based on major and minor scales, modes, all diatonic qualities of triads and seventh chords. Styles will include Baroque through Contemporary art music, folk melodies, popular tunes, and the blues. Performance of these will provide students with the opportunity to approach the musical arts creatively and with the highest of standards. Upon completion of this course, students will be able to demonstrate the following competencies:

- Illustrate proficient keyboard technique through the performance of scales, arpeggios, and other technical studies
- Demonstrate comfort with treble and bass clef notation through proficient sight reading and manipulation of short musical phrases
- Employ harmonization, keyboard theory, and transposition principles to accompany and modulate musical excerpts
- Demonstrate regular and expanding practice habits through the preparation and performance of repertoire pieces
- Create expanded improvisations within a given framework

Delivery Method:

This course meets face-to-face. Course material, assignments, and announcements may be offered via Canvas as a supplemental approach to learning at the discretion of the instructor. Grading

GCSC Grading Scale

Each faculty member will explain the grading system employed in each course (see below). Students are responsible for obtaining a clear understanding of this process. Final grades are available the week after the end of each term. Students may access grades in Student Dashboard through MyGCSC. All grades will be posted in the student grade book in Canvas and will be assigned according to the following scale:

- A 90%-100%
- B 80%-89%
- C 70%-79%
- D 60%-69%
- F 59% and below

Calculation of Grades

Grades will be taken from three proficiency exams. Each exam will take place one-on-one. The exam will have seven components including technique, repertoire, sight reading, harmonization, transposition, keyboard theory, and improvisation, and you will receive a grade for each category. Your final course grade will be an average of all three sets of exam grades (21 grades total for 10 points for a total of 210 possible points). The only factor to play into your final grade besides the proficiency exams is your daily attendance/punctuality. Tentative exam dates for the semester are as follows:

- Proficiency I – Week Six during Class Time
- Proficiency II – Week Twelve during Class Time
- Proficiency III – Week of Final Exams during posted Final Time

Attendance Policy

Regular class attendance and participation are significant factors that help to promote success in college. Students are expected to attend all class meetings of all courses for which they are registered.

You are expected to know the instructor's specific attendance policy, as stated in the syllabus for each course. In the event of absence, you should contact your instructor as soon as possible to indicate the reason and to inquire whether make-up work is possible. (Make-up work is offered solely at the discretion of your professor.)

If your absences in a class become excessive, as stated in the course syllabus, your professor may contact you, indicating that further absence may result in your withdrawal from the course. Your professor can withdraw you from a course for excessive absences without your permission.

Instructors will monitor attendance at the beginning of each semester. If you are not in attendance during this period, you may be withdrawn from the course. You will be financially responsible for the course and a "W or NS" will appear on your transcript. Withdrawal from a course may also have implications for financial aid.

Make-Up Work Policy

Regular participation in class materials is expected. Course materials for classes are released in an intentional order and within a specific time frame that aligns with assessment dates. Although frequent, low-risk assessments can help make the grading process more equitable, it would be preposterous to believe all of the information covered in class could make its way on to a grade somewhere. However, new information rarely does well in a vacuum. The connections we make in discussion boards, listening activities, and personal explorations will make the heavier graded portions of our content all the more accessible to you. As such, extended, uncommunicated absences will result in a lower final grade. **When absences are communicated in advance of due dates and equitability can be maintained with your colleagues, make-up work may be permitted.**

Withdrawal Policy

Two withdrawals are permitted per credit course. After that, a grade will be assigned. Please be concerned about withdrawals. When admitting students into certain programs, universities may calculate withdrawals as grades. It is your responsibility to verify the effects of enrollment and/or withdrawal upon your financial assistance (financial aid, scholarships, grants, etc.). There are two kinds of withdrawals---student and administrative.

- *Student Withdrawal (W1)* - Students wishing to withdraw must complete the online Student Withdrawal Form before the scheduled withdrawal deadline as published in the College catalog. Student withdrawals initiated prior to the scheduled withdrawal deadline will be recorded as a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.
- *Administrative Withdrawal (W2)* – A faculty member may withdraw a student up to the published withdrawal deadline for violation of the class attendance policy in which case the student will receive a grade of "W." The withdrawal deadline for an off-term or condensed term is one week after midterm.

Students cannot withdraw from developmental studies courses (college-preparatory classes) after the drop/add period without written permission from their instructor and/or their academic advisor.

Academic Integrity

Honest participation in academic endeavors fosters an environment in which optimal learning can take place and is consistent with the college's mission. Academic misconduct, including cheating or plagiarism, is destructive to the spirit of an educational environment. GCSC professors report every instance of student academic misconduct to the college for inclusion on the student's records. Most course syllabi include an academic honesty policy and the consequences for violating this policy. Familiarize yourself with course policies regarding authorized or unauthorized use of AI to avoid the pitfalls of academic dishonesty.

The following definitions will apply:

"Cheating"

includes but is not limited to use of any unauthorized assistance in taking quizzes, tests, or examinations; dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; the acquisition without permission of tests or other academic materials belonging to a member of the College's faculty.

"Plagiarism"

includes, but is not limited to, the use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment as well as the purchase of papers or projects. It can also include overuse of an editing program like Grammarly or submitting work written by an Artificial Intelligence (AI) generator like ChatGPT. Make certain to consult your course syllabi for your instructor's guidelines of AI material.

"Self-plagiarism"

occurs when a student submits the same or considerably similar document to fulfill requirements in different classes. For example, if a student submits a term paper in Religion they originally wrote for an English class, this is self-plagiarism. Once a paper receives a grade in one class, it cannot be submitted again for another class.

"Generative Artificial Intelligence (AI)"

is technology that uses machine learning to create new content, such as text, images or code, based on user input. These systems are trained on vast amounts of data, including large language models and image or code generators. Common examples include ChatGPT, GitHub, Copilot, Google Gemini, Perplexity, and the Grammarly AI function.

Sanctions for incidences of academic misconduct, depending on the severity of the incidence and/or its repetition, may range from receiving an F grade (or 0) for the test, assignment, or activity, to failure of the course, to suspension or dismissal from the college.

Classroom Recording

In accordance with federal and state privacy laws, students may record class lectures for their own personal educational use, in connection with a complaint to the college, or as evidence in internal or external legal proceedings. Students may not publish or upload the recordings or any components
