How to Request an old Army or Air Force Leave and Earnings Statement

If you need an OLD Leave and Earnings Statement (LES), there are a few ways to get them. Here's how:

- If you are an ACTIVE DUTY military member, you'll need to go to your Local Finance Office and SUBMIT your request.
- If you are **SEPARATED** from the **Army** or **Air Force**, a member of the **Reserves** or **National Guard**, please read through the information below and follow the links.
